# Handfasting Ceremony Inclusion



Bride & Groom have chosen to include the ancient Celtic ritual of handfasting in their wedding ceremony; it is where the expression 'tying the knot' originated. This is a symbolic ceremony to acknowledge the intertwining of their lives and represent their commitment to each other for a long and happy life together.

Bride & Groom have selected four colors making up the Hand Tying cord with the Lover's Knot. (Drape cord over hands)

Blue : representing tranquility, patience, and devotion

Will you honor each other? We will.

Will you seek never to give cause to break that honor? Yes.

And so the binding of honor is made.

Green: representing fertility, prosperity, and nurturing

Will you share each other's dreams? We will.

Will you dream together to create new realities and hopes? Yes.

And so the binding of vision is made.

Gold: representing wealth, intelligence, and longevity

Will you share each other's laughter? We will.

Will both of you look for the brightness in life and the positive in each other? Yes.

And so the binding of optimism is made.

White: representing purity, concentration, and peace

Will you share the burdens of each so that your spirits may grow in this union? Yes.

And so the binding of sharing is made.

The tying of the Lover's Knot is complete. Bride & Groom will grab the ends and tighten. As the knot tightens it strengthens the bond of your relationship.

Woven into this cord, imbued into its very fibers, are all the hopes of your friends and family, and of yourselves, for your new life together. With the fashioning of this knot are all the desires, dreams, love, and happiness wished here in this place for you. The knots are not formed by these cords, but rather by your vows. For as always, you hold in your own hands the making or breaking of this union.



Bless these hands that you see before you on this day.

May they always reach out with love, gentleness, and respect always being held by one another.

And may they build a loving relationship that lasts a lifetime.

Bride & Groom as your hands are bound together now,

so your lives and spirits are joined in a union of love and trust.

Above you are the stars and below you is the earth.

Like the stars, your love should be a constant source of light, and the earth, a firm foundation from which to grow.

## Suggestions for Officiants

- Always look at the Marriage License before signing. Make sure that it does not have a watermark that indicates "This is not a valid Marriage License". If possible bring this to the couple's attention when they receive it from the City/Town Clerk.
- Always make a copy of the marriage license before submitting to the City/Town Clerk.
- Take a picture of the couple for your records.
- Make sure you have tissue or a hankie readily available for tearful brides...and grooms!
- If the wedding is to be held in the same room as the reception, strongly urge the couple to keep the bar totally closed until after the ceremony. If the bar is available, people will cluster around the bar. If a guest has a choice between ordering one more drink or sitting down for the ceremony, for many guests, the bar wins. It is not an easy task to get everyone to leave the bar and to sit down in a timely manner for the ceremony to begin.

Good Public Speaking, Good Listening, Organization, Resourcefulness, Reliability, Patience, Humor, and Flexibility. A good knowledge of wedding styles, choices and laws are necessary, too.
