

## "Justice Evolved: How AI is Revolutionizing the Role of Justices of the Peace" James McKim, PMP, ITI

Guest speaker James McKim, Jr., gave an outstanding presentation to NHJPA members and guests, exploring the evolution of artificial intelligence (AI) technology from as far back as 1943, marking the beginning of machine intelligence. He guided us through the advancements in AI up to the present day.

He highlighted various resources, such as Grammarly Al, ChatGPT, and Perplexity Al, among others. He discussed the potential benefits of Al, including increased efficiency and innovation, while also addressing concerns related to privacy and job displacement. Overall, his presentation offered valuable insights into the changing landscape of artificial intelligence.

Mr. McKim addressed the topic of Al applications for Justices of the Peace. We were truly inspired by the possibilities for and beyond enhancing our work writing customized wedding ceremonies through the use of Al. This led to a very active conversation leading to a very productive question-and-answer session.

## Wedding Market Grows by 4.2%

The wedding market grew by 4.2% from 2023 to 2024, with spending on attire and accessories increasing, particularly for tuxedos and suits (+5.3%) and wedding dresses (+2.1%). However, couples are becoming more budget-conscious:

- 66.5% are trimming their wedding budget to some extent.
- 50% are reducing their guest list, prioritizing quality over quantity.
- Average guest counts are declining—from 134 in 2023 to 131 in 2024, with early 2025 data showing a further drop to 127 guests.

Couples today are spending smarter, focusing their budget on what truly matters to them. The guest list reduction reflects a shift toward more intimate, curated wedding experiences rather than large-scale celebrations. While costs are being cut in some areas, couples continue to invest in meaningful, high-quality purchases - attire, photography, and premium experiences.

For wedding businesses, this means a fundamental shift in how couples approach spending:

- Smaller guest lists mean more per-guest spending.
- Luxury and personalization take priority over traditional large weddings.
- Vendors who offer flexible, high-value packages will have the advantage.

The latest results are based on 19,914 data samples including behavioral and survey data collected in 2024.

All markets have been updated to 2024 data and 2025 and 2026 forecasts have been updated as well. Number of weddings will be updated later this year as we still do not have final numbers on weddings.

## A Wedding Day Memoire

### The Double-Double Ring Ceremony Extravaganza!

Last summer, 2024, I had the opportunity to perform a double ring ceremony. It all began when a couple reached out to me through my wife. She knew the groom's mother, and they didn't have a venue for their ceremony and needed a Justice of the Peace. Coincidentally, the date chosen was during the week we were on vacation at our camp at Lake Winnisquam. With the Airbnb host's permission, I was able to proceed with the ceremony.

A week before the wedding, the groom's best man contacted me with a request. Since he and his fiancée had been lifelong friends, they wanted to get married as well, making it a double-double ring ceremony. I reached out to the first couple, and they were thrilled about the idea.

To make the occasion even more special, my wife decided to create a handmade bouquet for the bride. The brides shared the bouquet made during their vows and photography. We also brought along a bottle of champagne to celebrate.

I held the ceremony on our dock, where the couples faced the water as I officiated. I had already written the vows for the original couple, and quickly wrote a second set of vows the night before, for the second couple. One of the gifts I do for the Bride and Groom is print it on parchment paper scroll and notarize it and frame it for them. I did this for both couples. It was an incredible experience!



## Suggestions for Officiants

- Always check the Marriage License before signing. Ensure it does not have a watermark stating, "This is not a valid Marriage License." If possible, bring this to the couple's attention when they receive it from the City/Town Clerk.
- Always make a copy of the marriage license before submitting it to the City/Town Clerk.
- Take a picture of the couple for your records.
- Keep tissues or a handkerchief on-hand for tearful brides and grooms!
- If the wedding is to be held in the same room as the reception, strongly encourage the couple to keep the bar closed until after the ceremony. If the bar is open, guests may gather around it, and many may choose to order another drink instead of sitting down for the ceremony. This can make it difficult to get everyone seated in a timely manner when it's time for the ceremony to begin.

#### What Makes a Great Officiant?

To be a successful Justice of the Peace, you need to develop key skills: public speaking, listening, organization, resourcefulness, reliability, patience, humor, and flexibility. You also need a good understanding of wedding styles, options, and laws. NHJPA offers helpful information in these areas.
